8.047/14 Chair's Report

Chairman's Report

Matters since last meeting

1. The licence regarding the Garage at Argoed Sports is still outstanding. The Secretary of the association contacted the Clerk to query whether we had submitted the licence to County Hall the Clerk forwarded the e-mail sent in to County Hall in August to the association. A member drew the Council's attention that football posts were leaning against the garage and made it inaccessible.

Resolved: The Clerk to write to the junior football and the Argoed Sports Association demanding a clear access to the garage.

- 2. Flintshire County Forum was a success with around 50 attending and spoke about mainly asset transfers a copy of which has been received by members. It was acknowledged that five members of the Council attended and found the meeting interesting. "The White Ribbon day" was explained at the meeting and the Council has agreed to acknowledge support.
- 3. The Clerk acknowledged the petition in relation to the work to be carried out in the quarry and wrote to each household explaining the current status. Some called to express their concerns regarding the wetland and the Clerk explained that plans have not yet been finalised. Some commented that they had no objection to the water being installed. Main concern seems to be about the wetland and the effect of insects it attracts.
- 4. The water supply to the quarry is valid up to February Dŵr Cymru confirmed. If were unable to do it before then the Council should contact them nearer the time for an extension.
- 5. The Local Development Plan Committee met on the 22nd of October concerned mainly about the development of a form. Could a member of the committee update the meeting. Members explained the development of the form to Council and discussed the variety of ways to distribute the questionnaire and providing internet access to the form. The internet format would suit the Council best as the software would collate and sort the replies to provide informative results.
- 6. The Christmas tree for New Brighton has been purchased and planted.
- 7. Around 1500 bulbs have been delivered and are being planted in the quarry and should show results next year.
- 8. Ysgol Mynydd Isa has confirmed that they will be attending the Christmas Carol Concert on the 5th of December. The Clerk was asked to let FLVC know about the concert and to have an advert on the Website.
- 9. The Vice-Chair and Clerk held a meeting with Flintshire County Council regarding the transfer of assets. It was an information gathering meeting to see what was available and the way forward. A list of assets in the Argoed area has been provided to the Council, which the Council considered insufficient to be able to make a decision and the Clerk should request another list with further information.
- 10. CCTV the cameras above the Kitchen door will be corrected on the 7th of November as well as the software on the Clerk's Computer.
