Incident update - (from 04/09/2018 to 02/10/2018)

Anti-Social Behaviour Issues/Trends:

13/09/2018 – Report of a group of youths smoking cannabis in the bushes on Watts Dyke Park. Officer attended and spoke with a few youths but no evidence of smoking cannabis.

14/09/2018 – Report of a known group of youths entering property and taunting youth. Some of the youths have apologised to the victim and the school is aware of the incident and of all parties involved. The mother of the victim is happy for there to be no further action.

15/09/2018 – Report of a male that has defecated on the pavement. The male was caught on CCTV and has been identified and will be interviewed. Investigation on-going.

Crime Issues / Trends

12/09/2018 & 27/09/2018 – Criminal damage – Reports of metal fence being damaged in Wats Dyke Park. No CCTV, no witnesses. Suspects still remain unidentified.

19/09/2018 – Road disruption – Report of a tree that had fallen and blocked the road. Highways made aware to clear the road.

26/09/2018 – **Road disruption** – Report of a vehicle parked in a lay by on fire. NWFR attended to put out the fire. Officers attended and managed the traffic.

Other News/PCSO activities:

Each year, NWP are able to apply for funding for Operation BANG in order to facilitate activities for the young people over the Halloween and Bonfire night period. The Arson Reduction Team and the Police and Community Trust (PACT) funding enables neighbourhood policing teams to reduce the demands of the staff (of all emergency services) during this busy time of the year. The operation also aims to reduce ASB and the setting of fires/ using fireworks etc in an area. Last year, the operation was very successful as there was a reduction in ASB and fire/ arson incidents and positive relationships were formed between staff members, NWP and young people.

As there have been a number of criminal damage and ASB incidents at/ near the ARGOED Social club/ Sports Association recently, PCSO Sammi has organised sporting activities to take place at the location. This is in an attempt to encourage the young people to participate in the activities whilst engaging with NWP and the staff members of the Sports Association. The sporting activities will include zorb football and panna cage football, and will be free of charge to the young people.

The sporting activities and coaching will be provided by AURA Leisure and Libraries and will take place on Friday 26th October 2018. Before the sporting activities, PCSO Sammi will have a discussion with the young people about the consequences of setting fires and they will participate in a quiz. This will commence at 16:00 hours and the sporting activities will commence at 17:15 hours.
