8. Chairman's Report.

a) Matters since last meeting

- 1. JAH confirmed that he had met PCSO recently and that the laptop computers had been handed over, which would enable her to monitor cameras.
- 2. Broken milk bottles: it appeared that concerns over stacks of milk bottles left by the side of the road had been dealt with and the problem had not recurred.
- 3. Defibrillator Training: the training session at New Brighton Community Centre had been well attended and deemed a great success.
- 4. Defibrillators: the two defibrillators which had been acquired by ACC were in the office and should be sent out for installation at New Brighton and Argoed Sports Club.
- 5. Jon McCarron had asked about the possibility of providing some First Aid Training for members of the local community. It was agreed that this was a worthwhile project and

that JM is to look into possibilities of training by St John's ambulance/British Red Cross or similar and ascertain cost.

Resolved: ACC would contribute to the cost if this training, when known.

9. Notices of Motion

1. Query has been raised as to whether Welsh Water encouraged the installation and use of meters to encourage reduction in waste of scarce resource. It was agreed that although not a significant local problem (water shortage), parts of the UK were at serious risk of shortages and that ACC should play its part in encouraging reduction in wastage/usage. It was thought that all new properties automatically had a meter installed.

Resolved: the Clerk should write to Welsh Water, asking for the policy on installation.

2. Redbud: the letter from Redbud regarding payments was noted and agreed that we needed to discuss with Michelle in greater detail. Different terms should not be introduced part way through currency of existing subcontract.

Anti-Social Behaviour Issues/ Trends:

15/03/2019 – Informant received an abusive phone call (on Englefield Crescent) from an unknown person enquiring about the informant's internet connection. Officers attended and provided reassurance to the informant. Advice also given e.g call blocker.

21/03/2019 – Female attended location on Bryn Offa Lane to attend a course but was late so was rejected resulting in the female refusing to leave the location. Female was calmed down by a staff member at the location. Officers were not required to attend.

Crime Issues / Trends

06/03/2019 – Reports of a male knocking on individual's properties on Bryn Road asking to sell household items. Officers attended and spoke with the male. Checks carried out. Male was wanted for other offence. Male arrested. Second male involved and checks carried out. Male was also stop searched and had similar household items on him. No offences.

07/03/2019 – Male congregated in between a hedge and fence near to the Argoed school yard. Officers attended but negative sightings of the male. Staff at the school made aware. Location added to officer's patrol plan. 07/03/2019 – Report of a dagger/ cross symbol painted on a lamppost on Bryn Road. Officer attended to provide reassurance and crime prevention advice. Photograph taken of the mark and sent to FCC to make them aware. Information sent to officers currently on Operation Lexus (targeting suspicious vehicles linked to burglaries) to patrol the area.

10/03/2019 – Report of fraudulent activity on informant's bank account. Crime prevention advice given. Advised to report to Action Fraud. CCTV enquiries made where the transactions were made. Relative of the informant identified. Informant wanted to confront the individual herself.

22/03/2019 – Portable cabin broken into overnight on Bryn Road. Nothing taken but items thrown around. CCTV opportunities. Crime prevention advice given. Nothing for CSI. On-going investigation.

b) North Wales Wildlife Trust

It was noted that they had proposed schedule of planting for the Memorial Garden and it was agreed that they should be asked to go ahead in September.
