**Presentation** received from Flintshire County Council Officers: Sam Tulley, Streetscene Maintenance Manager (Central and Roadspace) and Mark Edwards, Area Coordinator, Streetscene and Transportation regarding the pilot 20mph scheme:

- The area covering New Brighton, Bryn-y-Baal and Mynydd Isa will be part of 1 of 8 pilot schemes within Wales.
- Flintshire County Council ("FCC") are working with Welsh Government ("WG") at the moment as a consistent approach across all authorities is wanted. No time-scales as of yet but it is hoped to have it all in place by the summer.
- Our bid was made strong by the number of schools in the area.
- The road from Buckley to Mold cannot be included, notwithstanding the number of children crossing it, as it is a classified road and must remain at 30mph. This is a pilot scheme however and may be tweaked going forward.
- The support of the police will be needed for this to work properly.
- The effectiveness of the 20mph will be about percentages and bringing the average speed of the road down.
- There will be two parts to the public consultations; notices and advertising on FCC's website, with maps and showing all the roads that will be affected.





# 3. Update on Planters and Hanging Baskets

Clerk advised that a quote has been received for an octagonal planter with Argoed Community Council and the logo, two x metre square planters with logo and an additional 3 hanging baskets, to complete the display in New Brighton. This totals £1,311.35 plus VAT. Therefore, additional funding needs to be obtained from full Council in order to also purchase the two window boxes for the village entry signs. There is currently no authority to purchase more planters than those already listed. There was an alternative proposal to plant daffodils alongside Bryn Road again, hopefully with some community engagement, given the volunteers who helped with planting daffodils in the Memorial Garden. It was noted that the North Wales Wildflower Trust have promised bulbs for autumn.

It was noted that a letter has been sent to the Fuschia and Geranium Society and to the Argoed Gardening Club asking for assistance with plants and planting. Plants are being donated by the Fuschia and Geranium Society and there are four volunteers to help with planting up the hanging baskets.

Recommended: Clerk to add agenda item requesting the additional funding to the next meeting's agenda.

That the budget is reviewed early 2022 to ascertain whether planters may be purchased for Bryn Road, Bryn-y-Baal

Assistant Clerk to make enquiries as to whether any grants or donations would go towards the daffodil proposal.

## 4. Review of Wildflower Garden

It was noted that the planter provided is broken and needs fixing. The feature is also looking rather messy and unkempt. The obligation to maintain the feature for 5 years was also noted.

Recommended: That the school gardening club is asked to help maintain it.
