1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

In 2021-22, the Council made payments totalling £1,800 under section 137. These payments are included within 'Other payments' in the Accounting Statement.





On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

Approval of the Accounting Statement

The Council is required to approve its accounts each year. The Annual Return indicates that the accounting statement was approved on 9 May 2022. However, my examination of the minutes for the meeting held on 9 May identified that the Council only approved a report from the Internal Auditor. The minutes record:

The Clerk detailed all the payments that needed to be authorised and discussed the External Auditor reports for 2019/20 and 2020/21 and the Internal Auditor report for 2021/22 in detail.
