**The following information is provided to assist the reader to understand the accounting statement and/or the Annual Governance Statement**

### 1. Expenditure under S137 Local Government Act 1972

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2024-25 was £10.81 per elector.

In 2024-25, the Council made payments totalling £824 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

2. The Council has not formally developed and approved a 'vision' statement and linked this to their budget and expenditure plans. At the Council meeting on 2 July it was agreed that a 'vision' would be developed and approved over the next 6 months and the views of the community would be sought.
3. A Training Plan was only approved at the Council meeting on 2 July 2025.
4. The 2023-24 external audit identified that Members Interests were not published on the Council's website. This is currently being addressed and it is anticipated that it will be published in August 2025.
5. Internal Audit testing identified occasions when SO's and FRs were not complied with.
6. Authorisation of payments outside of a meeting needs to be formalised in a Delegated Arrangements Policy. Internal Audit testing of payments identified that authorisation processes were insufficient in some cases.


